

Consignor Agreement

(Please read carefully before signing.)

I have read and agree to the following consignment sale rules, as well as all directions outlined in the consignor information detailed on the sale website, www.northwoodmops.com.

Consignment Sale Rules:

- All sales are final.
- Sale officials reserve the right to reject any item that does not meet the standards of the sale.
- Consignor assumes all responsibility for theft, loss and damage of items, except items specifically guaranteed by sale officials.
- Each consignor must complete and submit a Consignor Agreement in addition to any items for sale.
- Consignor is responsible for verifying his/her mailing address at drop-off. If a proceeds check is mailed to the wrong address, any resulting costs will be the full responsibility of the consignor.
- Proceeds checks will be mailed to consignors within 15 business days from the date of the sale. Consignors then have 10 business days to alert sale officials to any discrepancies.

_____ I understand that Northwood Temple MOPS will earn 35% of the sales price of my items, and I will earn 65% of the sales price of my items. I further understand that Northwood Temple MOPS will deduct a \$3.00 consignor fee from my proceeds check to cover advertising and other expenses that help to sell my items.

_____ I agree to collect all unsold yellow-tagged items AT THE APPOINTED TIME ON SATURDAY. I understand that NO EXCEPTIONS CAN BE MADE TO PICK UP ITEMS AFTER CONSIGNOR PICK-UP CLOSES.

_____ I understand that ONLY unsold items with YELLOW TAGS will be returned to me at the above pick-up time. Unsold items tagged with any other color WILL BE DONATED.

_____ If my check is less than \$5.00, I consent to donating the proceeds to Northwood Temple MOPS. (This is OPTIONAL.)

_____ I understand that any proceeds check not cashed within 90 days is null and void. I am responsible for reporting undelivered or lost proceeds checks immediately to the consignor coordinator.

_____ I understand and agree that Northwood Temple MOPS is not responsible for loss or theft of items except those explicitly guaranteed and checked in. Northwood Temple MOPS is also not responsible for items damaged during the sale.

Participation in the Friday afternoon Consignors' Preview Sale is limited to the person to whom the consignor number is issued (and a spouse or assistant.) If the consignor is an organization, one person must be designated as the shopper at drop-off.
